NOTIFICATION

In view of the recent surge of the COVID-19 cases in the State of Arunachal Pradesh and in order to ensure preventive course in premises of the Gauhati High Court, Itanagar Permanent Bench, Naharlagun, the Hon'ble Gauhati High Court has been pleased to issue following guidelines, with regards to functioning of Courts in the Itanagar Permanent Bench, Naharlagun:

- 1. The Court shall function in hybrid mode, so as to avoid footfalls and to maintain social distancing.
- 2. Only those lawyers, whose names appear in the cause list/Vakalatnama and who will be appearing in the case, the petitioners-in-person, members of staff, security staff, etc. shall be allowed to enter the High Court premises.
- 3. Only limited number of cases will be listed. Mention may be made on the mention form for urgent listing of cases (At Annexure-I) either offline or online at the *itanagarbenchjudicialsection@gmail.com* for mentioning cases showing the urgency before the Court. The Court, only on being satisfied that the matter is of urgent nature, shall direct for listing such cases also.
- 4. Compulsory wearing of mask and maintaining social distancing is mandatory within the premises of the High Court.
- 5. Bar room shall remain open by adhering to COVID-19 up to date protocols issued by the competent authority. The Bar Association shall give an undertaking to the Registrar that all COVID-19 protocols shall be maintained and that they shall be responsible for adhering to the COVID-19 guidelines issued by the competent authority.
- 6. Lawyers shall leave the Bar room after completion of their work and in no case shall they remain in the Bar room for more than 2 Hours.

- 7. Canteen shall operate in a restricted mode with only take away facility.
- 8. Cases filed physically shall be kept under quarantine for at least 02(two) days before being listed. Very urgent listing will be allowed, provided softcopy is submitted/filed.

These guidelines shall come into effect immediately and shall remain in force until further order(s).
