Other terms and conditions which are not specifically mentioned herein shall be governed by the relevant Rules and Orders in force from time to time.

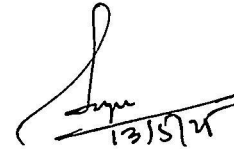
